



REGATTA TOOLBOX – REGATTA MANAGEMENT SYSTEM

FEATURES:

- **WEBSITE HOSTING**
 - NOR, SAILING INSTRUCTIONS, COMPETITOR LISTS, OFFICIAL NOTICE BOARD AND RESULTS
 - REGATTA ORGANIZERS CAN POST INFORMATION TO WEBSITE THEMSELVES WITHOUT THE NEED OF OUTSIDE WEBMASTER SUPPORT
- **ONLINE REGISTRATION SYSTEM** ALLOWING COMPETITORS TO PAY ENTRY FEES USING EITHER STRIPE (similar to Paypal & GiftTool) OR YACHT CLUB MEMBER ACCOUNTS
- **ABILITY TO LINK SOCIAL MEDIA ACCOUNTS (TWITTER, INSTAGRAM, YOUTUBE) TO YOUR REGATTA WEBSITE**
 - ALLOWS FAMILY AND FRIENDS TO FOLLOW REGATTA ON SHORE OR AT HOME
- **200 x RFID WRIST BANDS AND 2 SCANNERS TO ELECTRONICALLY SIGN IN / SIGN OUT SAILORS ON AND OFF THE WATER**
 - IMPROVED SAILOR SAFETY!
 - STATUS OF ALL SAILORS CAN BE FOLLOWED ON THE REGATTA WEBSITE BY REGATTA ORGANIZERS OR SAFETY OFFICERS
- **2 x iPADS WITH SIM CARDS AND DATA PLANS**
 - ON THE WATER SCORING DONE ON iPADS
 - RESULTS POSTED TO WEBSITE MINUTES AFTER THE COMPLETION OF EACH RACE
- **FULL INTEGRATION BETWEEN ONLINE REGISTRATION SYSTEM, SCORING SYSTEM, WRIST BAND SIGN IN / SIGN OUT MODULE**
 - NO MORE EXPORTING COMPETITOR INFORMATION FROM PAYPAL OR GIFTTOOL INTO EXCEL AND THEN IMPORTING INTO SAILWAVE!!!

COST:

- **7% FEE ON CREDIT AND DEBIT CARD REGISTRATION PAYMENTS**
 - **NO FEES CHARGED ON REGATTA ENTRY FEES COLLECTED VIA YACHT CLUB MEMBER ACCOUNTS**
 - NOTE: SOME YACHT CLUBS CHARGE AN ADMINISTRATION FEE TO COMPETITORS PAYING USING YC ACCOUNTS
- **COURIER CHARGES IF YOU WANT THE REGATTA TOOLBOX HARDWARE SENT TO YOUR REGATTA LOCATION**

III. Borrower Responsibilities

This Agreement and the responsibilities as outlined hereunder are not transferable without the written approval of Lender. By executing this Agreement, the Borrower agrees to comply with the terms set forth below:

A. Insurance

The Borrower is responsible for the full cost of repair or replacement of any or all of the Equipment that is damaged, lost, confiscated, or stolen from the time Borrower assumes custody until it is returned to Lender. If the Equipment is lost, stolen or damaged, Borrower agrees to promptly notify BC Sailing.

B. Use/Disclaimer

The Borrower shall be responsible for the proper use and deployment of the Equipment. The Borrower shall be responsible for training anyone using the Equipment on the proper use of the Equipment.

C. Delivery and Return of Equipment

Title to the Equipment listed in this Agreement shall remain with Lender. The Borrower shall be responsible for the safe packaging, shipping and receiving of the Equipment. The Equipment shall be returned within a reasonable amount of time after the Loan Period end date identified above.

The Borrower is responsible for all courier charges to have the equipment shipped to their event as well as courier charges to have the equipment returned to BC Sailing.

D. Replacement due to damage or loss

Equipment shall be returned to Lender in as good a condition as when received by the Borrower. During the loan period and prior to return, the Borrower agrees to assume all responsibility for equipment replacement due to breakage or loss.

This Agreement cannot be amended or modified except in writing signed by both parties. Any attempt to do so except in accordance with this paragraph shall be void.
